19. How will the LEA ensure Continuity of Services?*

Briefly describe an overview of the continuity of services and in the following questions you will provide more detailed information.

The Prescott Unified School District provides in-person learning for students during the 2023-2024 school year as its primary model of instruction for most students. Services including but not limited to student academic needs and student and staff social emotional mental health and including food services will continue to be provided regardless of circumstances. PUSD Everywhere is a Distance learning program designed to reach students who may have schedule limitations or are otherwise unable to attend in person or are only able to attend on a hybrid schedule. After-school tutoring will take place throughout the school year with limited transportation available for students. During the school day, staff will be engaging students in intervention opportunities to narrow the learning gap that may have happened during the school closures and hybrid schedules. Summer school will be offered to students in need of additional intervention and enrichment and also includes transportation. Enrichment field trips for students have been provided, including Farm to School Program activities, garden clubs, 21st Century clubs, and Challenge Program.

20. How will the LEA ensure continuity of services for students' academic needs?*

Provide direct Instruction and small group focused instruction, and supplemental or intensive interventions based on student needs. Independent and project-based learning may be used to supplement or extend direct instruction. Formative and summative assessments will be used to determine student academic progress and growth.

21. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

For the 2023-2024 school year. PUSD continues to support students' well-being and health needs will be supported in both in-person and distance learning environments. Counseling and social worker staff are available at school sites to assist with the assessment of students' needs, provide social-emotional support in collaboration with classroom teachers and connect families with outside agencies and resources. In PUSD, social and emotional support has always been a critical component of our educational vision. Students are encouraged to build their relationships with school staff and their peers through our established programs like Capturing Kids' Hearts and Kids At Hope. Our highly qualified counselors and other dedicated staff are ready to help students with their well-being needs.

22. How will the LEA ensure continuity of services for students' other needs?*

Each school employs a registered nurse to support student health. Food services are available (breakfast and lunch) to all students at all school sites.

The PUSD's District Wellness Committee (DWC), develops the local wellness policy, creates measurable wellness goals, assists the district with the implementation of wellness goals, and updates the local wellness policy as needed. Currently, the DWC consists of PUSD administrators, employees, parent volunteers, and community partners. Our District Wellness Coordinator provides staff engagement opportunities for living healthy lifestyles. Our HR Benefits Coordinator provides health assessment opportunities and ways to maximize staff medical benefits. The Prescott Unified School District offers all employees an Employee Assistance Program.
